- Prohibitions. -- For the period of time that a property is receiving a tax exemption under this program, no purchase or sale of the property or any portion thereof shall be structured in a manner that excludes or exempts the transaction from a realty transfer tax due to any taxing authority that would otherwise not be excluded or exempt, except in the following cases:
 - a sheriff sale or tax claim bureau sale; (1)
- (2) a corrective deed; 10
- (3) a transfer by the mortgagor to the holder of a bona 11 fide mortgage in default in lieu of a foreclosure; 12
 - a transfer to a judicial sale in which the successful bidder is the bona fide holder of a mortgage; or
- (5) any other transaction excluded from the realty 15 transfer tax under Article XI-C of the act of March 4, 1971 16 (P.L.6, No.2), known as the Tax Reform Code of 1971. 17
